To amend the Act of August 9, 1955, to modify the authorized purposes and term period of tribal leases, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Unlocking Native
- 5 Lands and Opportunities for Commerce and Key Eco-
- 6 nomic Developments Act of 2023".

1	SEC. 2. MODIFICATION OF TRIBAL LEASES AND RIGHTS-OF-
2	WAY ACROSS INDIAN LAND.
3	(a) Extension of Tribal Lease Period.—The
4	first section of the Act of August 9, 1955 (69 Stat. 539,
5	chapter 615; 25 U.S.C. 415) (commonly known as the
6	"Long-Term Leasing Act") is amended—
7	(1) by striking "That (a)" and all that follows
8	through the end of subsection (a) and inserting the
9	following:
10	"SECTION 1. LEASES OF RESTRICTED LAND.
11	"(a) Authorized Purposes; Term; Approval by
12	Secretary.—
13	"(1) In General.—Any restricted Indian
14	lands, regardless of whether that land is tribally or
15	individually owned, may be leased by the Indian
16	owner of the land, with the approval of the Sec-
17	retary, for—
18	"(A) a public, religious, educational, rec-
19	reational, residential, business, or grazing pur-
20	poses; or
21	"(B) a farming purpose that requires the
22	making of a substantial investment in the im-
23	provement of the land for the production of 1
24	or more specialized crops as determined by the
25	Secretary.

1	"(2) Inclusions.—A lease under paragraph
2	(1) may include the development or use of natural
3	resources in connection with operations under that
4	lease.
5	"(3) TERM.—
6	"(A) IN GENERAL.—Except as provided in
7	subparagraph (B), a lease under paragraph (1)
8	shall be for a term of not more than 99 years,
9	including any renewals.
10	"(B) Exception for grazing pur-
11	Poses.—A lease under paragraph (1) for graz-
12	ing purposes may be for a term of not more
13	than 10 years, including any renewals.
14	"(4) Requirement.—Each lease and renewal
15	under this subsection shall be made in accordance
16	with such terms and regulations as may be pre-
17	scribed by the Secretary.
18	"(5) CONDITIONS FOR APPROVAL.—Before the
19	approval of any lease or renewal of an existing lease
20	pursuant to this subsection, the Secretary shall de-
21	termine that adequate consideration has been given
22	to—
23	"(A) relationship between the use of the
24	leased lands and the use of neighboring land;

1	"(B) the height, quality, and safety of any
2	structures or other facilities to be constructed
3	on the leased land;
4	"(C) the availability of police and fire pro-
5	tection and other services on the leased land;
6	"(D) the availability of judicial forums for
7	all criminal and civil causes of action arising on
8	the leased land; and
9	"(E) the effects on the environment of the
10	uses to which the leased lands will be subject.";
11	(2) in subsection (b)—
12	(A) by striking "(b) Any lease" and insert-
13	ing the following:
14	"(b) Exception for Secretary Approval.—Any
15	lease'';
16	(B) by striking "of the Interior" each
17	place it appears; and
18	(C) by striking "clause (3)" and inserting
19	"paragraph";
20	(3) by redesignating subsections (a), (b), (c),
21	and (d) as subsections (b), (e), (d), and (a), respec-
22	tively, and moving the subsections so as to appear
23	in alphabetical order; and
24	(4) by striking "subsection (a)" each place it
25	appears and inserting "subsection (b)".
